






### Population by Age Cohort




- ▶ Middletown's population has increased by more than 2,000 in the last four years.

### Characteristics by Age




- ▶ Age and gender distribution of our population affect patterns of disease.

- ▶ 88% of Middletown residents 25 and over have a high school diploma, GED or higher education.
- ▶ Middletown's higher degree percentage is 4% higher than the state average, and 3% higher than the county.
- ▶ 15% or about 2,000 of our residents 25 and over have no high school degree or GED, which is near double that of the state and county.




## Marital Status & Household Type




## Limited English-Speaking Households

Percentage of All Households







**Median Income, 2021**




- ▶ Per capita income is used to determine the average per-person income and to evaluate the standard of living and quality of life of the population.




## Individual Poverty










## Housing Cost Burden

Cost burden is the ratio of housing costs to household income. For renters, housing cost is gross rent (contract rent plus utilities). For owners, housing cost is "select monthly owner costs", which includes mortgage payment, utilities, association fees, insurance, and real estate taxes.



- ▶ Only 74% of residents 19-25 years old have Health Insurance Coverage.




- ▶ Results show that 13% of Middletown residents rate their PHYSICAL HEALTH as NOT GOOD.

# Access to Health Care

## Adult Preventative Services

- Current lack of health insurance among adults aged 18–64 years
- Visits to doctor for routine checkup within the past year among adults aged  $\geq 18$  years
- Older adult women aged  $\geq 65$  years who are up to date on a core set of clinical preventive services: Flu shot past year, PPV shot ever, Colorectal cancer screening, and Mammogram past 2 years
- Older adult men aged  $\geq 65$  years who are up to date on a core set of clinical preventive services: Flu shot past year, PPV shot ever, Colorectal cancer screening



- ▶ 78% of Middletown residents have visited a doctor for a routine checkup in the past year between the ages of 18-64.





Clinicians/100,000 Population, 2021-2022




Adult Care Clinicians/100,000 Population, 2021-2022






- Chronic conditions often lead to acute crises resulting in hospitalization, or long-term dependency care or death.

# Leading Causes of Deaths in Adults

## Top 3 Leading Causes of Adult Death, 5-year Rate

Heart disease is the leading cause of death for men, women, and people of most racial and ethnic groups in the United States. One person dies every 34 seconds in the United States from cardiovascular disease. About 697,000 people in the United States died from heart disease in 2020—that's 1 in every 5 deaths.



Motor vehicle accidents, falls, poisoning, suicide, homicide, drowning, fire, suffocation, firearms, explosions, mining, equipment malfunctions, medical malpractice, air, train or water transport.

- ▶ Heart disease is the leading cause of death for men, women and people of most racial and ethnic groups in the US.
- ▶ One person dies every 24 seconds in the US from heart disease.

### 1. Intros

- a. Everyone introduce yourself!
- b. We are here today to share the Community Health Assessment results which are a combination of state data and local data collected through surveys.
- c. You are here with us today so we can share these results and show you where Middletown ranks within the county and state in a multitude of public health aspects.
- d. You each have information in front of you that includes local resources in English and Spanish and a reminder of the upcoming Free Health Screening at the Middletown Library and two surveys we need you to complete before you go. All surveys are anonymous and we truly appreciate your feedback! 1
- e. Remember, we will have future focus groups and there are incentives if you refer a friend or bring a friend to the next group meeting. Thank you to the three of you that brought someone with you today!
- f. Today's meeting is all men. That is by design because we did not get a large number of responses from men, men of color and/or young men with our full survey. So we need you to join in and share your thoughts on the health and wellness of Middletown.
- g. Participation and conversation is key in helping our department learn if the results of the assessment are a true reflection of our city's health in your opinion and learning what YOU think our priorities are moving forward with our public health improvement plans for the next four years!

## 2. Presentation

- a. All data has been included in the presentation with Middletown specific results highlights and notes are included on each slide. The Community Health Assessment is a county wide project that includes all of Butler County and the cities of Hamilton and Middletown. Today, we are focused on Middletown!
- b. Feel free to speak up during the presentation at any time! Once the presentation is complete, we will talk it out. So think about the following things as you see the results. You all have post-its in front of you to write down your thoughts as we move forward.

## 3. Discussion-Round Table

- a. Participant-We need more education. They do not teach you about insurance in high school. They do not teach you about life insurance either. Specifically speaking of people in the 18-26 age group. My mom got remarried and I had to get my own health insurance. I did not have any idea where to start or what I needed. They don't teach you about insurance, budgeting, finances in school. Seems like everyone waits until something goes wrong and then you have to try to figure it out on your own.
- b. Participant-Bring back career day.
- c. Participant-I agree, I think that if you are married or in a relationship, the woman makes sure you go to the doctor. The mother or sister or girlfriend/wife is usually the one to make the men take better care of themselves. Men need to learn to take care of

themselves and not just do it because someone else tells you to. You take care of your kids, we need to do better at taking care of ourselves too.

- d. Participant-More life skills education is needed. We need more groups like this where we can use peer support to lift each other up. Schools need to offer more education in these areas so we can break the cycles.
- e. Participant-Kids are having kids. If they had no strong role model growing up, they will not be a good role model to their kid and on and on. We need to break this cycle up. Men need to stop feeling like they are on an island. We can support each other and share resources and be role models for each other. I am about to be 67 years old and I am in better shape than my grandkids.
- f. Participant-Today's youth do not have the same type of outdoor and physical activities we had when we grew up. Kids are staying in the house and on the phone/computer. There is no exercising or staying outside until the lights come on and you have to go in. We need to get youth and young adults back to being physically active.
- g. Participant-We need to take better care of ourselves and be physically active too.
- h. Parks needs more activities. Things that young kids are interested in that will get them out of their house. Our parks are underutilized and not always clean. Some parks aren't safe to have kids at by themselves.
- i. Participant-Structure in the home impacts health. It also impacts your ability to work, finances and your mental health. Most homes don't have both parents, and parents that aren't at work all the time leaving the kids unsupervised to do whatever they want or get in trouble.
- j. Participant-I am surprised by the employment and housing data. There are no good jobs in Middletown. I drive an hour to work every day to be able to pay my rent and bills. How can we expect to break the cycle if you can find a job that pays enough for you to stay and work in Middletown?
- k. Participant- I disagree with the rent data. Rent is not \$700 in Middletown. If you want a two bedroom here you are going to pay at least \$1,200-\$2,900.
- l. Participant-High school graduates that don't go to college end up getting jobs at fast

food restaurants. That is not a career in most cases. The cycle will never break when these educated young men get stuck in these jobs. This causes all kinds of health issues like depression, and not going to the doctor because they can't afford it, not eating healthy because it's too expensive, not getting enough sleep etc.

- m. If you rent in Middletown, you are potentially homeless. You could be out on the streets with no notice and nowhere to go. The median income vs cost of housing is not doable with the jobs available.
- n. Participant-I am surprised that the poverty rate is higher in Middletown than in Hamilton.
- o. Participant-Surprised and saddened to see 30% of families with children in Middletown are below the poverty line.
- p. Participant- Median income in Middletown does not seem right.
- q. Participant- over 15% with no high school diploma-that effects everything in a negative way health, family, future, mental status, crime, drugs and so on.
- r. Participant-I would like more data on the suicides rates in Middletown and how they compare to Butler County and Hamilton. What causes suicides? Is it depression? Is it clinical depression or undiagnosed depression? Is it a result of other issues like drugs and alcohol? We need to dig deeper into this.
- s. Participant- People have struggles. Creating a safe space where men like us can get together and help and support each other is where we can start. If you don't have a health intervention, you may turn to crime, alcohol, drugs etc.
- t. CMHD-50% of all Americans suffer from some type of depression. We all have issues. Talking about it helps. Lean on each other.
- u. Participant-I am surprised by the heart disease rates and that is such a common cause of death. We need more education on how to avoid/prevent this.
- v. Participant-I like getting a group of men together like this so we can talk things out. We need to have more of this so we can take better care of ourselves and each other and be part of the solutions. I know Jackie and her team. I have worked with them before and I know they will get things done. They don't just talk about doing things, they do them.

w. Participant- Can I get a copy of this presentation? Yes, it will be posted on our website!

## 678: Weeds

Noxious Weeds - all grass, weeds and wild plants exceeding six inches in height

- Except as specifically permitted Russian, Canadian, or common thistle, wild lettuce, wild mustard, wild parsley, ragweed, milkweed, iron weed, and all other noxious weeds growing on any lot or lands are a public nuisance. Every owner, occupant, or person in control of any lots or lands shall keep the property free from such noxious weeds by cutting them or by destroying them by spraying with a chemical compound approved by the Commissioner of Health, and then removing said cut or destroyed noxious weeds from such property.

### 678.05 Exemption

Undeveloped lots or parcels of land five acres or more, regardless of Zoning district, are excluded. If located adjacent to private residences, businesses, or public rights-of-way, the exemption shall not apply to a strip of land 20 feet in width closest to such private residences, businesses or public rights-of-way.

## 660.045 ACCUMULATION OF RUBBISH, GARBAGE OR LITTER

Every owner and/or occupant of real property shall maintain such property in a clean and sanitary condition. The owner and/or occupant shall not permit the accumulation of rubbish, garbage or litter upon said property, except when such rubbish, garbage or litter is contained in a container as described in Section 1066.05 of the Codified Ordinances. The accumulation of rubbish, garbage or litter is a public nuisance, subject to abatement.



### DEFINITION

Rubbish: Combustible and noncombustible waste materials, except garbage; the term shall include the residue from the burning of wood, coal, coke, and other combustible materials, paper, rags, cartons, boxes, wood, excelsior, rubber, leather, tree branches, yard trimmings, tin cans, metals, mineral matter, glass, crockery and dust and other similar materials.

### DEFINITION

Garbage: The animal or vegetable waste resulting from the handling, preparation, cooking, and consumption of food.



# Tips for Homeowners from City of Middletown Code Enforcement Team

## Tips:

1. Wrap and seal upholstered furniture in plastic for pickup.
2. Television sets cannot exceed 32 inches.
3. Brush must be bundled/tied, no longer than 4 feet, and not exceeding 50 lbs.
4. Carpet must be cut to lengths not to exceed 4 feet and tied/secured.

## 1066.05 GARBAGE AND REFUSE CANS

- Garbage or rubbish, or containers containing garbage or rubbish cannot be placed at the curbside more than 48 hours prior to the scheduled pick-up.
- Empty containers used for the disposal of garbage and rubbish must be removed from the public right-of-way within 24 hours after scheduled pick-up.
- Ord. 4935, passed 6-3-1969; Am. Ord. O2007-26, passed 3-20-2007; Am. Ord. O2008-27, passed 4-1- 2008; Am. Ord. O2013-71, passed 12-17-2013

## Chapter 1218: Parking, Access, and Mobility 1218.03(h)(3)

Except for temporary parking permitted as part of a temporary use of any pervious surface, all open off-street parking areas shall be graded and provided with a hard surface of asphaltic, bituminous cement, concrete or other properly bound pavement so as to provide a durable and dustless surface, including private parking areas on residential lots.

Middletown Development Code Effective Date: March 1, 2018

Parking on the grass is prohibited and can result in a civil penalty of \$150.00 for a first offense and \$250.00 for the second and subsequent offenses, or you may be cited into court.

## **1030.01 TRIMMING OF TREES, ETC. OVERHANGING PUBLIC STREETS, SIDEWALKS AND LATERAL STRIPS**

- The owner shall trim or cause the tree, plant or shrub to be trimmed so that a clear height of 12 feet between the lowest branches of the same and the street or alley level is maintained, and so that a clear height of nine feet between the lowest branches of the same and the sidewalk, lateral strip or other public right-of-way is maintained.
- The owner shall trim or remove, as the case may require, every dead, decayed or broken tree, plant or shrub, or part thereof, so that the same will not fall to the street, sidewalk, lateral strip or other public right-of-way.
- The owner shall cut down and remove any tree, plant or shrub, or part thereof, as may be necessary to provide a clear and unobstructed view of traffic from all directions at any street intersection, or to abate any nuisance necessary to protect the life, limb or property of persons, drivers of any vehicles, or pedestrians using the street, sidewalk, lateral strip or other public right-of-way.

Ord. 2001-100, passed 9-4-2001

The City of Middletown does not offer curbside leaf pickup. Rumpke will remove bags of leaves with their weekly pickup.

Tree disputes along property lines are a civil matter between property owners.

# Tips for Homeowners from City of Middletown Code Enforcement Team

## Chapter 1218: Parking, Access and Mobility - 1218.03(i)

### Parking and Storage of Major Recreational Equipment and Large Utility Trailers (Residential Zoning Districts)

Parking or storage of major recreational equipment or large utility trailers in any front yard of a dwelling within 35 feet of the right-of-way line is prohibited. Temporary parking is allowed for a period of 72 hours within any seven consecutive days for loading and unloading purposes.

Major recreational equipment, the related trailers, and large utility trailers may be parked or stored outdoors in the side or rear yard of a residential premises, provided that:

- All vehicles and trailers shall be parked or stored in a single location on the premises; and all parking spaces shall meet the surface requirement specified in Section 1218.03(h). Alternative hard surface brick or interlocking paver material may be used.

The vehicle or trailer shall be properly licensed and registered for highway use as required by the State, and the vehicle shall be maintained in good condition so that it can be readily transported (wheels shall not be removed; tires shall not be flat; and the vehicle shall not be fixed to the ground).



Major recreational equipment or large utility trailers may be parked or stored, in any condition, within a fully enclosed garage that is located in accordance with Section 1206.01.

No business shall be conducted within major recreational equipment while it is parked on residential premises.

No major recreational equipment shall be used for dwelling purposes.

# Tips for Homeowners from City of Middletown Code Enforcement Team



## 660.21 YARD MAINTENANCE

- Furniture, mattresses, household furnishing, rugs, appliances shall not be placed or stored in any yard area contiguous to any structure or on any porch, patio, deck, or other outdoor structure, which is not enclosed for more than 48 hours. This prohibition does not apply to furniture or rugs which are designed for outdoor use.
- Exterior property areas of all premises in the City shall be kept free of objects, materials or conditions that: create a health, accident or fire hazard; constitute a public nuisance; or, are a blighting or deteriorating influence on the neighborhood. Broken glass, filth, garbage, rubbish and debris shall not be permitted to remain on any property.

# Tips for Homeowners from City of Middletown Code Enforcement Team

## 660.075 STORAGE OF AUTOMOBILE PARTS OR TIRES IN PUBLIC VIEW

- No person shall display, store or maintain automobile parts or tires for any vehicle, whether new or used, in a place which is open to the public view, unless the area where the automobile parts or tires are displayed, stored or maintained is inside an enclosed structure, such as a building, garage, etc. The PUBLIC VIEW means that the automobile parts or tires are visible from any residential property, other than the property where the parts or tires are stored or maintained, from a public street or alley, or from any other public place.
- For the purpose of this section, a TIRE includes a solid tire or pneumatic tire for any type of vehicle, as defined in Ohio R.C. 4501.01(A).
- Ord. 2001-32, passed 3-20-2001

### **PENALTY:**

Minor misdemeanor on the first offense; if the offender has been previously convicted of violating this section, the offender shall be guilty of a fourth degree misdemeanor. The Court may order the offender to remove all parts or tires to a place where they may be lawfully stored and/or maintained, and may, upon failure to comply by the offender, authorize the City to remove the parts and tires at the expense of the offender.

This section does not prohibit the seller of new or used tires from displaying tires for sale in the public view, so long as the tires are displayed only during the seller's regular hours of operation and are removed from public view.
